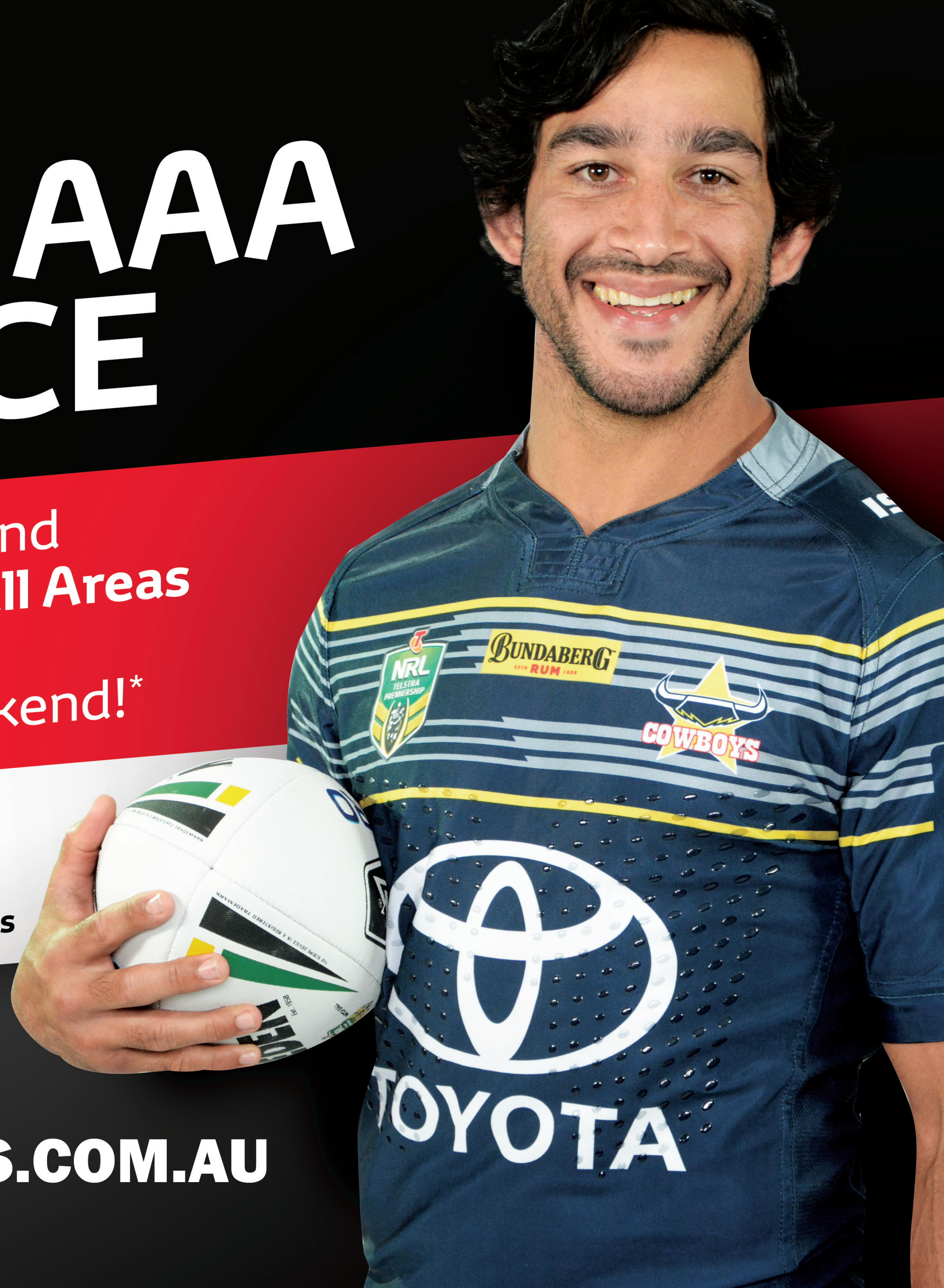

# Terms and conditions of entry - “Toyota Cowboys AAA Experience”

2. Entry is open to Australian residents who purchase and take delivery of any new Toyota vehicle between 1st April and 30th April 2018. Directors, management and the employees of the Promoter and agencies, retailers and suppliers associated with this promotion and the immediate family members of these people are ineligible to enter.

3. The competition commences on 1st April 2018 and concludes on the 30th April 2018. All new Toyota vehicles that are sold, registered and delivered to eligible private and ABN customers at participating dealers during the competition period are eligible for the promotion. While stocks last.

4. To enter: Purchase and take delivery of any new Toyota vehicle from a participating North Queensland Toyota dealership between 1 April and 30 April 2018 and you will automatically go in the draw. Only private and ABN customers are eligible. While stocks last.
